- ("Class Representatives" or "Plaintiffs") in this litigation against Nationstar Mortgage LLC and Veripro Solutions Inc. ("Defendants"). I have personal knowledge of the information stated below, based on my participation in the litigation and my review of the file, and am competent to testify thereto.
 - 2. My law firm, Kemnitzer Barron & Krieg LLP, has extensive experience representing consumers in class actions and unfair business litigation. I make this declaration in support of Plaintiffs' Motion for Attorneys' Fees in this action.
 - 3. The facts and procedural history stated in the accompanying memorandum in support of this motion are accurate to the best of my knowledge based upon my review of the file, discussions with opposing counsel and co-counsel, evaluation of documents produced, research and discovery in this matter.

I. PLAINTIFFS ARE ENTITLED TO ATTORNEYS' FEES AND COSTS

- 4. Paragraph 4.6 of the Settlement Agreement reads as follows:
 - Plaintiffs will be considered the prevailing parties and Class Counsel will be entitled to an award of Attorneys' Fees and Expenses as provided in this subsection. Concurrently with the mailing of the Class Notice, Class Counsel may apply to the Court for an award of Attorneys' Fees and Expenses not to exceed \$390,000. Defendants may oppose such application, but will pay an Attorney's Fees and Expenses award in the amount awarded by the Court, not to exceed \$390,000, for all services provided on behalf of the Class Representatives and the Settlement Class. Defendants shall issue an IRS Form 1099-MISC solely to the respective Class Counsel for the amount paid to such counsel pursuant to this section and to no other person or entity. Notwithstanding the foregoing, Defendants may issue additional Form 1099-MISCs to other persons or entities only if ordered to do so by the IRS, and any compliance by Defendants with such an order or requirement shall not be a breach of this Agreement. If ordered to issue any Form 1099-MISCs to other persons or entities by the IRS, Defendants shall provide documentation of any such order or requirement to Class Counsel. Class Counsel shall be solely and legally responsible to pay any and all applicable taxes on their attorneys' fees award and shall hold harmless Defendants, and counsel for Defendants, from any claim or liability for taxes, penalties, or interest arising from their attorneys' fee award.
 - (b) Class Counsel shall be solely responsible for paying any monies due to any and all other counsel for Plaintiffs and the Class, out of the Attorneys' Fees and Expenses approved by the Court. Defendants shall not be liable for any claims ensuing from the distribution of the Attorneys' Fees and Expenses.
 - (c) Class Counsel and the Class Representatives expressly disclaim any right to recover attorneys' fees and costs in the Action in excess of the amount awarded by the Court from any person or entity. Class Counsel and the Class Representatives agree that the amounts of such Attorneys' Fees and Expenses

awarded shall compensate them for all legal work in the Action up to and including the Effective Date, as well as for all legal work and costs that may be incurred in the Action after the Effective Date.

(d) This Settlement is not conditioned upon the Court awarding the amounts sought by Class Counsel as an award of Attorneys' Fees and Expenses. If the amount awarded by the Court is less than what was sought by Class Counsel, the remaining provisions of this Settlement Agreement shall be binding and effective.

II. FEES AND COSTS INCURRED; REQUEST FOR FEES AND COSTS

5. In this case, as of November 19, 2021, Class Counsel has put in 712.00 *audited* hours of attorney and staff time, totaling \$439,525.00 in fees, and \$17,762.34 in out-of-pocket expenses prosecuting this matter.¹

III. USE OF BILLQUICK FOR TIME SLIPS

- 7. Our firm utilizes computer software called "BillQuick" that assists in keeping track of actual time expended in performing various legal tasks on any given case. Our firm bills in minimum increments of one tenth of an hour (0.1), or six minutes. We do not round up.
- 8. Insofar as the records of fees, costs, and expenses are concerned regarding each individual case file in the office, I am a custodian of those records. These time records are

- routinely prepared in the ordinary course of business, by the individuals with personal knowledge of the tasks performed and who have the responsibility to enter their time into the computer, at or near the time each task is actually performed.
- 9. In my role as Managing Partner, I used billing judgment to ensure that all time expended on this case was necessary to reach the excellent settlement obtained. I extensively reviewed every single one of our firms' billing entries for this case and cut all time I deemed to be excessive or unnecessary for the prosecution of this matter.
- 10. I removed one partner's time who billed fewer than five hours to the case, and five separate support staff's time totaling more than fifty-three hours. I also reviewed all detailed time entries for the remaining staff and attorneys, removed unclear or unnecessary billing entries, and otherwise used my billing judgment in order to ensure that only necessary time entries remained.
- 12 | 11. In total, I cut over 107 hours of time, totaling 52,778.50 in lodestar.
 - 12. Within BillQuick, staff and attorneys use task-based billing codes to categorize time.

13. KBK's "L100" billing category includes Class Counsel's work performed assessing and developing the theories underlying the case and performing the paralegal and development tasks necessary to prosecute and resolve the case. Accordingly, one of the paramount aspects of this billing category is that it includes Class Counsel's pre-litigation meetings with the potential client, the assessment as to the viability of the potential case, and paralegal time during the prosecution of the case. KBK is *very* selective with respect to cases it takes, agreeing to represent less than 5% of potential clients who contact our office. This billing category also includes time spent on paralegal tasks performed by Class Counsel's senior paralegal working on this matter. All of the time spent performing the tasks in this billing category is documented extensively in Class Counsel's billing records. In all, Class Counsel's attorneys and staff spent 97.7 hours and \$32,595.00 performing work in this billing category.

<u>L160 – Settlement/Non-Binding ADR</u>

14. The "L160" billing category includes time Class Counsel spent preparing for and participating in the mediation and two settlement conferences in this case as well as time spent

preparing and negotiating the terms of a highly technical settlement agreement, together with the exhibits thereto, and working extensively with opposing counsel to complete the settlement. In all, Class Counsel's attorneys and staff spent 145.80 hours and \$101,265.00 performing work in this billing category.

<u>L200 – Pre-Trial Pleadings and Motions</u>

15. The "L200" billing category includes the time Class Counsel's attorneys and staff expended on drafting, reviewing, revising, and finalizing (i) the complaint; (ii) Motion for Remand; (iii) Motion for Class Certification; (iv) Opposition to Motion for Summary Judgment; (v) Opposition to Motion to Exclude Expert (vi) Motion for Preliminary Approval; (vi) status conference statements, and (vii) the instant Motion for Attorneys' fees and Costs. It also includes the time Class Counsel spent preparing for and attending hearings in this matter. This billing category also will include the time Class Counsel will spend preparing for and attending the final approval hearing. In all, Class Counsel's attorneys and staff have spent 349.90 hours and \$228,752.50 performing work in this billing category, but anticipate these amounts will increase as Class Counsel has yet to complete the final approval papers and anticipates that the class action approval process and work necessary to implement the settlement will increase the lodestar by approximately \$30,000.00 based on the remaining work necessary to bring the case to conclusion.

<u>L300 – Discovery</u>

This case involved extensive discovery, as set forth in greater detail in the Declaration of Arthur Levy and the Points and Authorities. The Class Counsel's attorneys and staff spent 118.60 hours and \$76,912.50 performing work in this billing category.

IV. CLASS COUNSEL'S EXPERIENCE

16. Our law office has extensive experience in consumer class action litigation, including having tried a class action to judgment. Our law office has been appointed as lead counsel in over 250 class actions. Class Counsel has decades of experience in consumer issues, and has specialized in class actions for most of their lengthy careers

1	17. Kemnitzer, Barron & Krieg's attorneys' hourly rates include many factors beyond personal
2	compensation, including office staff, equipment, insurance, research materials, and other overhead
3	expenses. The firm does not charge separately for secretarial time and other clerical costs, which are
4	also included in the hourly rate. Consumer litigation inevitably involves large corporations, which
5	have the capacity to bring enormous resources to bear that individual consumers are simply unable
6	to meet on their own. The partners manage this law firm to meet those challenges. This involves,
7	among other things IT costs, investigation and research costs that are much higher than those a mo
8	generalized small firm might employ. This overhead is also included in attorneys' hourly rate. This
9	particular case could not have been brought and prosecuted, without this extensive support
LO	foundation included in overhead.
L1	18. In contrast to the defense bar, in which attorneys compete for clients, there are not enough
L2	plaintiffs' attorneys specializing in consumer protection litigation to meet the need. Kemnitzer,
L3	Barron & Krieg takes fewer than 5% of the cases for clients who contact our office. The firm turns
L4	away some meritorious cases for lack of resources.
L5	19. The firm spends a significant amount of time researching the merits of the case prior to
L6	filing a complaint, in order to ensure that we only file meritorious complaints. Therefore, a
L7	significant but necessary amount of time is spent conducting research on all factual and legal
L8	aspects of the case prior to filing.
L9	20. Kemnitzer, Barron & Krieg, LLP is a boutique plaintiffs' firm. Currently, we have four
